



## **Dallastown Area School District 1:1 Device Agreement**

For students and families of 4<sup>th</sup> – 12<sup>th</sup> grade students

### **Student Agreement**

As a learner, I agree that I will:

- Use my 1:1 device for educational purposes.
- Follow the procedures and policies outlined in the 1:1 Device Guide and Dallastown Area School District Acceptable Use Agreement both at school and at home.
- Protect my 1:1 device by carrying it securely in the District-issued case and preventing careless or malicious damage.
- Never leave my 1:1 device unattended in an unsecure or unsupervised location.
- Charge my 1:1 device's battery to full capacity each night.
- Report all damages, issues, or technical problems with my 1:1 device to my instructor.
- Not alter or attempt to change, disable, or circumvent the management settings, content filters, or any protective settings on my 1:1 device.
- Never share my 1:1 device with other students or individuals.

I understand the device is the property of the District and that any violation of this Agreement may result in the suspension or loss of my 1:1 device and school network privileges. Additionally, I may face disciplinary action, as determined by school administration, for any violations of this Agreement, or the policies, rules, or regulations of the District, up to and including suspension or expulsion.

### **Parent Agreement**

I understand that my family's responsibilities include:

- Ensuring my child meets the expectations outlined in the 1:1 Device Guide and the Dallastown Area School District Acceptable Use Agreement.
- Properly storing, transporting, and protecting the 1:1 device, within reason, against damage, loss or theft while it is at home or outside of school.
- Ensuring my child immediately reports damage to his/her instructor.

In consideration of the privileges and opportunities afforded by the use of DASD technology resources, I hereby release the DASD, its employees and directors from any and all claims of any nature arising from my child's use or inability to use these resources, including but not limited to claims that may arise from unauthorized use of a 1:1 device. I also understand that it is impossible

for DASD to restrict access to all controversial materials and I will not hold the District responsible for materials accessed with a District 1:1 device.

I accept full responsibility for my child's use of the 1:1 device while not in a school setting and understand that my child's 1:1 device use is subject to the same rules and requirements when used off-campus. I understand that my child's 1:1 device privileges may be suspended or revoked for violation of this Agreement. I also understand that my child may be subject to disciplinary action for conduct in violation of this Agreement, or the policies, rules, or regulations of the District.

### **Optional Maintenance Plan**

In order to support the 24/7 use of a 1:1 device by our students and to help maintain them, families/students have the opportunity to purchase a \$25 annual maintenance plan. With this plan,

- The District will provide coverage for repair or replacement of the 1:1 device in the event of accidental damage (*this does not include the charger and case*).
- Students having subsequent damages and/or a pattern of repeat 'accidental' damages, may be held financially responsible for the repairs. (Building administrators will review each case and when such a pattern is established, the student/family will receive a warning)
- The maintenance fee does NOT provide coverage for the loss of the 1:1 device and/or damage to its accessories, cosmetic damage, or damages caused by intentional misuse, abuse or careless handling.
- Any device reported to the District as stolen should be accompanied by a police report.
- Students will be responsible for the full cost of repair/replacement if it is determined that damage has been caused by intentional abuse, misuse or careless handling.
- The District reserves the right to request parents/guardians to pay additional fees based on a history of repeated claims for loss, theft and damage.
- I understand that should damage occur to the 1:1 device assigned to my child due to intentional damage or careless use, I will be solely responsible for reimbursing the school for repair or replacement cost.

*\*\*Students/families choosing not to purchase a maintenance plan would be responsible for the full-cost to repair/replace a device that is damaged, destroyed, lost, or stolen.*

### **Replacement/Repair**

- All replacements and repairs are to be completed by the DASD technical staff only. Students/families should not attempt to make physical repairs themselves nor use a third party to make device repairs.
- All replacement and repairs of the 1:1 device, charger and case that are found to be from manufacturer defect, will be replaced/repared at no cost to the student/family.
- Damaged chargers and cases are the responsibility of the student/family. These items are sold in each of our participating schools.
